5. Discussion of current status of the Claymore and Smithdale Roadway Improvements.

John Peterson updated Council on the progress of the Claymore and Smithdale Roadway project and stated that the project was going to come in at anywhere from 8-10% under budget.

6. Discuss and take possible action on the approval of the proposal for Professional Services on the Blalock/S. Piney Point Proposal.
