### CITIZENS WISHING TO ADDRESS COUNCIL -

1. Consider and take action on the monthly Memorial Villages Police Department report.

Police Chief Walpole was in attendance and reported on the Memorial Villages Police Department activity during the last month.

2. Discuss and take possible action regarding a 2011 transfer to balance the budget and complete the Memorial Villages Police Department audit.

Chief Walpole presented this item to City Council.

Motion was made by Councilman Kollenberg to approve the Intra-budgetary transfer on the audit as spelled out in Chief Walpole's memo of Sept. 18, 2012. (Copy of memo included below in these same minutes) The motion was seconded by Mayor Pro Tem Ebeling and passed unanimously.

SUBJECT: Interbudgetary Transfer

The Department is in the final stages of completing the 2011 Police Budget Audit. In order to reconcile the 2011 budget, the following items need your attention.

#### ITEM 1:

The 2011 Police Budget was audited in August of 2012. It is projected that there will be a \$24,672.00 surplus from that budget, resulting in a refund of \$8,224.00 per city.

#### ITEM 2:

The Auto expense line item was \$22,953.00 over budget. This was due in part to unforeseen expenses in maintenance for two of the remaining Ford Crown Victoria patrol cars. In addition, based on Mayors' recommendation in conjunction with the inception of a new Police Chief, several patrol cars were painted with a new, highly visible paint scheme. Of the \$7,500.00 spent on painting the vehicles, \$2,500.00 was reimbursed through a donation.

Based on information received from the Auditor, I respectfully request Council approval of an interbudgetary transfer of funds as detailed below to balance this budget and complete the audit.

- Move \$14,600 from Building to Automotive
- Move \$4,900 from Office and Other Expenses to Automotive
- Move \$1,200 from Insurance to Automotive
- Move \$2,253 from Personnel to Automove

These requested transfers will balance the Department's 2011 budget and provide us with a clean audt. Your attention is appreciated.

Motion by Councilman Dodds to approve the engineering consistent with Option number 1 and allow HDR to move forward. The motion was seconded by Mayor Pro Tem Ebeling and passed unanimously.

Resident Kevin Keller spoke regarding the Green Oaks drive project.

Motion was made by Councilman Kollenberg to accept option number 2 for the Green Oaks Drive project and allow HDR to move forward with the final engineering. The motion was seconded by Mayor Pro Tem Ebeling and passed unanimously. Resident Lou Jacobs and Gary Fischmann spoke regarding the Jamestown Road project.

Motion was made by Councilman Dodds to accept option number 2 for the Jamestown Road project and allow HDR to move forward with the final engineering. The motion was seconded by Mayor Pro Tem Ebeling and passed unanimously.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF
PINEY POINT VILLAGE, TEXAS, AMENDING CHAPTER 62,
UTILITIES, TO ADD A NEW ARTICLE IV, PROVIDING
REGULATIONS PROHIBITING ILLICIT DISCHARGES INTO
THE MUNICIPAL SEPARATE STORM SEWER SYSTEM;
PROVIDING A PENALTY IN AN AMOUNT NOT TO EXCEED
\$2,000.00 FOR ANY VIOLATION OF ANY PROVISION OF THIS
ORDINANCE; REPEALING ALL ORDINANCES OR PARTS OF
ORDINANCES INCONSISTENT OR IN CONFLICT HEREWITH;
AND PROVIDING FOR SEVERABILITY.

Mayor Butler explained that there is still a critical West Nile threat in the region and we will continue to spray three times a week.
