THE CITY COUNCIL OF THE CITY OF PINEY POINT VILLAGE MET IN A SPECIAL MEETING ON TUESDAY, MAY 27, 2014 AT 6:30 P.M. AT CITY HALL, 7676 WOODWAY, SUITE 300 HOUSTON, TEXAS, 77063 TO DISCUSS THE AGENDA ITEMS LISTED BELOW.

DECLARATION OF QUORUM AND CALL TO ORDER: Mayor Lee Butler called the meeting to order at 6:30 p.m. Those present were: Henry Kollenberg, Mayor Pro Tem Ebeling, Dale Dodds, Ron Goodwine, City Administrator Ben Griffin, City Secretary Amanda Davenport, City Attorney David Olson and the City Engineers. Joel Bender was absent.

Judge Klevenhagen performed the swearing-in ceremony for Mayor Lee Butler and Councilman Henry Kollenberg.

Mayor Butler conducted the meeting with the agenda items in the following order:

8. Discuss and take possible action on the 2013 Fiscal Year Audit as presented to Council by Belt, Harris & Pechacek.

Motion was made by Councilman Kollenberg to accept the 2013 Audit as presented. Motion was seconded by Mayor Pro Tem Ebeling and passed unanimously.

6. Public hearing regarding the Special Use Permit request by the Kinkaid School to allow the general use and to permit private school use on the Milby Tract.
