Property address: 11326 Surrey Oaks Lane, Houston, Texas 77024. Variance request. To allow for a 25 ft. front yard building set back and a side yard setback of 10 ft.

(i) Fences and walls in required yards. No fence or freestanding fence-type wall shall permitted in any required yard except as specifically authorized. (1) Fences, front yard. Property address: 11103 Memorial Drive, Houston, Texas 77024. Variance request. To allow for a 6 ft. front yard, iron fence.
