THE SUBJECTS OF THE MEETING ARE AS FOLLOWS:

1.) CALL TO ORDER:

- 2.) <u>MEETING MINUTES:</u> Matters relating to the approval of minutes from the October 12th, 2017 regular session, Board of Adjustments meeting.
- 3.) VARIANCE REQUEST: Matters relating to a variance request from the City of Piney Point Zoning Ordinance, Reference Chapter 74 Section 244. Regulations. (4) Generator. If not located in the existing building lines, the generator may be located: a. on the ground. b. In the rear third of the lot. c. Ten feet from the property line. d. 5 ft. from the main structure. Resident and applicants: Mark and Deborah Kobelan. Property address: 12 Memorial Point, Houston, Texas 77024. Variance request. To allow for the generator to be set in the side yard, nine feet from the property line and the generator to be placed 3 feet from the main structure.
- 4.) VARIANCE REQUEST: Matters relating to a variance request from the City of Piney Point Zoning Ordinance, Reference Chapter 74 Section 245. Supplementary district regulations. (1) Fences, front yard. Fences and freestanding fence type walls may be constructed within a required front yard if not exceeding three feet in height; however, a fence not exceeding six feet in height above the natural grade of the lot at the lot line adjacent to such fence may be constructed within a required front yard if the front yard is adjacent to a four-lane, esplanade, curbed and guttered thoroughfare, the fence is set back at least three feet from the adjacent front lot line, and the fence is an 80 percent fence. Applicant: Keith Messick with Principal, Merge Architects, Inc; Residents: Ramin and Bahaar Sahami. Property address: 2002 South Piney Point Road, Houston, Texas 77024. Variance request: To allow for a solid fence type wall to be constructed and placed in a required front yard. The fence wall heights to be 7 ft., 10 ft. and 12 ft. tall. In front of the 50 ft. front yard setback.
